Selection Criteria

A. Investigator (Trainee)

1. Hold a degree, diploma, or technical qualification in one of the following fields:
 - Aviation
 - Aerospace engineering
 - Aircraft maintenance engineering
 - Electronics or avionics
 - Human factors
 - Safety management
 - Air traffic management
 - Other relevant technical discipline.

OR

Hold a professional aviation qualification, such as:

- Commercial Pilot Licence (CPL)
 - Aircraft Maintenance Engineer Licence (AME)
 - Air Traffic Control Licence.
2. Demonstrated experience in the aviation industry in operational or technical roles such as:
 - Flight operations
 - Aircraft maintenance
 - Air traffic services
 - Aviation safety
 - Aviation engineering or technical support.

B. Investigator (Direct Entry)

1. Educational Qualifications

Hold a degree or equivalent professional qualification in aviation, engineering, safety management, human factors, or another relevant technical discipline.

OR

Hold a professional aviation licence such as:

- Commercial Pilot Licence
 - Aircraft Maintenance Engineer Licence
 - Air Traffic Control Licence.
2. Minimum 5 years aviation industry operational experience, including operational or technical roles.

3. Experience participating in aircraft accident and incident investigations.
4. Sound understanding of aviation systems and operational environments aviation safety principles, accident and incident reporting processes, national and international aviation safety frameworks. Demonstrated ability to analyse technical information, identify safety issues, apply logical reasoning to operational problems.
5. Ability to prepare clear written reports, communicate effectively with aviation professionals, participate in interviews and evidence gathering.
6. Proficient in the use of Microsoft Office Suite (Word, Excel, PowerPoint, Outlook, etc.)

Application Process

To apply, submit a completed application containing the following documents:

1. A cover letter clearly stating the position being applied for and outlining the applicant's suitability for the role.
2. A detailed Curriculum Vitae (CV) including:
 - Personal contact details
 - Educational qualifications
 - Employment history
 - Relevant professional experience
 - Professional memberships (where applicable)
3. Certified copies of relevant qualifications and certificates.
