Selection Criteria

1. Hold or have held cabin safety qualifications. Have extensive cabin safety experience including management and training of Cabin Safety personnel. Desirable experience is 5 years operational
2. Wide-ranging knowledge of the aviation industry and related safety issues and national legislation, and a working knowledge of international conventions
3. Experience investigating aircraft accidents and serious incidents in accordance with ICAO Annex 13 Standards and Recommended Practices.
4. Demonstrated leadership ability and management skills including the ability to define, set and review objectives and report on the work of a team and the capacity to conduct investigations of aviation accidents and incidents.
5. Strong analytical, research, problem solving and advising skills with a focus on aviation safety.
6. Proven high integrity, and demonstrated application of strong ethical values, and sober habits.
7. Well-developed oral and written communication skills and demonstrated interpersonal skills of a high order, with the ability to liaise with a variety of individuals and organisational representatives from differing cultural backgrounds
8. Well-developed capacity for compiling concise, logical, considered and technically correct reports.
9. Experience using Microsoft applications such as Word, PowerPoint, Outlook, and Excel or similar.
10. Well-developed oral and written communication skills and demonstrated interpersonal skills of a high order, with the ability to liaise with a variety of individuals and organisational representatives from differing cultural backgrounds.
11. Demonstrated ability to compile concise, logical, considered and technically correct reports.
12. Working knowledge of accident and incident investigation practices. Experience investigating aircraft accidents and serious incidents in accordance with *ICAO Annex 13 Standards and Recommended Practices* would be an advantage.
13. Experience using Microsoft applications such as Word, PowerPoint, Outlook, Excel and Teams.
